## **REGIONAL PLANNING - -**

Municipal Code Chapter 206-53 Zoning Parking of Recreational Vehicles -

Discussion by the Village board on the Outcome of Vote from the Public Hearing for Municipal Code Chapter 206-53 Zoning Parking of Recreational Vehicles.

- S Byers stated that the League of Wisconsin Municipalities was contacted and we asked them to weigh in on the 2/3 majority requirement and heard back from them that because it's not down zoning where you're getting rid of a permitted use, you're merely placing limitations on use and that's perfectly acceptable and doesn't require a 2/3 majority.
- S Reignier commented "How is that not reducing a permitted use, right now currently the permitted use is that we can have what we want in our yards. If you pass a zoning ordinance that says I can't that is down zoning, that is reducing the permitted use."
- S Byers read her email dated June 22, 2016 and reply from Dan Olson representing the League of Wisconsin Municipalities regarding his opinion on State Statute Section 21.66.10015(1)(as).

After further discussion it was decided that Travis Coenen would take the State Statute Section 21.66.10015(1)(as) and the RV Ordinance and qualify whether the vote was accurate based on the state statute that was given and get an opinion from an attorney.
