UTILITY COMMISSION MONTHLY MEETING

Motion made by A Lundt with a second made by S Byer to open the Monthly Utility Commission Meeting. **Motion carried.**

WATER UTILITY

- Average of 157,000 gallons of water purchased, per day, from Green Bay Water, in the month of January
- Annual Emergency Management Reporting, on Tier II's for chlorine storage, completed
- Annual PSC Report completed in January and handed over to auditors
- Annual water loss for 2019 at 7%, however, non-revenue water loss jumped up to 16% due to four leaks, later found, in the distribution system

SEWER UTILITY

• Reviewed 2019 discharge numbers against 2018 numbers. High influent numbers and TP average due to record rainfall last year. A large amount of phosphorous was returned to the head of the plant, to allow room for wasting, as part of the dewatering process

Motion made by A Lundt with a second made by K Wendlandt to close the Monthly Utility Commission Meeting. **Motion carried.**

MINUTES – Motion by A Lundt with a second by S Byers to approve the January 21, 2020 Board Meeting Minutes. **Motion carried.**

VOUCHERS - Motion by S Byers with a second made by T Schaeuble to approve the vouchers, from January 16, 2020 through January 29, 2020 totaling \$149,401.23. **Motion carried.**

WALK-INS – Resident Rick Savela, 239 Peterlynn, requested an update on the status of the Village's NEW Light Pollution Ordinance. Administrator Coenen indicated that he is hoping to present

something to the Board in March, however, he is currently conferring with surrounding municipalities and is also working with Village Attorney Bob Gagan, as to how lighting violations, coming from existing buildings, will be addressed under the "Grandfather" clause. Complaints to municipalities are increasing as Wisconsin Public Service is requiring high sodium street light bulbs be changed out to LED bulbs, resulting in increased light pollution. Unfortunately, WPS did not take into consideration that LED lights "appear" brighter even though the photometric and projection is no different. Specific verbiage will need to be added to the Village's ordinance to make sure street lights with LED bulbs are correctly angled and shielded. The same issue will need to be addressed in residential areas as well, as property owners are switching over to LED bulbs for cost savings
