  - o Year end fund balance -\$64,882
  - o Projected closure based on current cash flow, is in 2028

- Year end fund balance -\$251.602
- o Projected closure based on current cash flow, is in 2035

## • Tax Incremental District #5

- o Created in 2018 as a Rehabilitation/Conservation District
- District not amended to date
- o Expenditure period ends in May 2041 with a mandatory termination date of May 1, 2046
- o Base value of district \$5,315,000
- o Incremental value as of January 1, 2020 was \$1,745,300
- o Year end fund balance -\$34,510
- o Projected closure based on current cash flow, is in 2025
- o District primarily encompasses the Village's downtown on both sides of the river
- o Tax Incremental District created to spur downtown development using improvement incentives
- o Projecting an additional \$3,880,300 in value will be added to the district in 2020
- \$410,000 in debt issued in 2019 for river bank stabilization work. Final payment scheduled for May of 2035
- Expenses for utility service installation for this area will need to be represented as TID 5 expenses. Audit adjustments to be made in 2020/2021
