# VILLAGE OF WRIGHTSTOWN BOARD MEETING MINUTES

The regular monthly meeting of the Village Board, of the Village of Wrightstown, was held at Wrightstown Village Hall, 352 High St., Wrightstown, WI, on **Tuesday, June 15, 2021.** 

Meeting was called to order at 6:00 p.m. by Village President Dean J. Erickson and the Pledge of Allegiance was recited.

**PUBLIC HEARING** – Motion made by K Wendlandt with a second made by S Byers to open the public hearing, to hear from all persons and/or their agents, on repealing in its entirety, Chapter 62 Village Board §62-11 Standing Committees and recreating Chapter 62 Village Board §62-11 Committee of the Whole. **Motion carried.** 

Three calls were made for public input with no response

Motion made by D Segerstrom with a second made by K Wendlandt to close the public hearing. **Motion carried.** 

**MINUTES** – Motion made by S Byers with a second made by T Schaeuble to approve the June 1, 2021 Board Meeting Minutes as submitted. **Motion carried.** 

**VOUCHERS** – Motion made by S Byers with a second made by T Schaeuble to approve the vouchers as submitted, totaling \$317,809.80, from May 27, 2021 through June 9, 2021. Trustee Keith Wendlandt inquired about the Coldwell Banker Real Estate Group invoice for \$74,671.00, paid on June 9, 2021, by Check #40639. Administrator Coenen indicated that the charges invoiced were for Coldwell Banker to co-broker the sale of Tinedale Farms, LLC tax parcels VW-W181-2 (Village of Wrightstown) and W-177 and W-179 (Town of Wrightstown). General fund "reserves" will be needed to cover the payment until TID No. 3 generates enough revenues to reimburse. Trustee Wendlandt also noted that Birschbach Inspection Service, Inc., has been paid \$60,143.92 so far in 2021. Administrator Coenen responded that Paul Birschbach is paid 85% of the total building permit fees collected from his work, while the Village retains 15%. This differs from the prior contract the Village had with Safebuilt, LLC, which was a 90%/10% split. Paid invoices for Robert E. Lee & Associates and McMahon Associates, Inc., for current development engineering services, totaled over \$140,000 in the last three months. **Motion carried.**

- Municipal Property Insurance Co. Primary Coverage Changes for 08/01/2021 08/1/2022
   Policy Term Following changes to MPIC primary property coverage for August 1, 2021
   through August 1, 2022 term were presented:
  - Earthquake coverage limited to \$5,000,000 policy aggregate. Also, new exclusion for losses stemming from earth movement related to mining operations that are not underground (*Prior: Earth movement coverage provided \$5,000,000 per occurrence. Slightly broader coverage provided for potential losses from mining operations*)
  - o Flood coverage limited to \$5,000,000 policy aggregate vs. \$5,000,000 per occurrence
  - o Property not covered now includes:
    - Underground storage tanks and tunnels
    - Vehicular bridges
    - Canals, seawalls and breakwaters for flood; earthquake; freezing, thawing, impact of watercraft; the pressure or weight of ice or water, whether driven by wind or not; and, erosion or deterioration, whether gradual or sudden
    - Amusement park rail systems and railroad track within 100' of a covered building
    - Overhead transmission, distribution or conductor lines
  - Earthquake and flood are excluded causes of loss for dams, pavements, swimming pools and related equipment, retaining walls, bulkheads, piers, bridges, canals, seawalls, breakwaters, wharves and docks
  - o "Malicious Programming" is now included in the list of losses excluded for property damage. This is unrelated to the coverage provided for data recovery. However, this loss is now covered under the Village's liability policy

The Village is also looking into increasing cyber liability coverage from \$10,000 to up to \$1,000,000. Application has been submitted and we are waiting for a response from the League of Wisconsin Municipalities Mutual Insurance with pricing quotes

- Robert E. Lee & Associates, Inc. Invoice No. 79603 Motion made by S Byers with a second made by T Schaeuble to approve Robert E. Lee & Associates, Inc. Invoice No. 79603, for \$15,642.89, for Midwest Expansion Residential Observation. Village is covering this cost as a guarantee that project is meeting expected standards. Motion carried.
- Midwest Expansion, LLP Invoice No. 20210603 Motion made by S Byers with a second made by K Wendlandt to move the Discussion/Action on Invoice No. 20210603 from Midwest Expansion, LLP, for \$18,342.30 for Closing Costs and Ag Conversion Fees on Midwest Expansion, LLP's parcel VW-W181-2, to after the closed session. Motion carried.
- Global Properties, LLC Incentive Payment Motion made by S Byers with a second made by T Schaeuble to approve the second incentive payment of \$63,470, due on June 23, 2021, to Global Properties, LLC, per the January 2021 Development Agreement. Although actual new increment is \$650,900 rather than the estimated \$634,700, payment is to be based on the estimate of \$634,700. Motion carried.
- NEW Wisconsin Act 32 Legal Newspaper Publishing Motion made by S Byers to publish required notices in the Wrightstown Spirit, once certification has been approved by the State of Wisconsin Department of Administration. No second was made. At the June 1, 2021 meeting, the Village Board of Trustees requested rate information and circulation counts for both the Wrightstown Spirit and the Brillion News. Newspapers certified with the State of Wisconsin Department of Administration are required to charge an established rate. At this time, the Wrightstown Spirit has applied for certification but a response has not yet been received. The Brillion News already has certified status. Circulation count for the Wrightstown Spirit is 1,057 households within the 54180 zip code while the Brillion News reaches 39 households in the 54180 zip code. Motion made by S Byers with a second made by K Wendlandt to table the motion and revisit if a positive response is received by the Wrightstown Spirit regarding certification. Motion carried. Compliment given by Trustee Sue Byers to Reporter Ed Byrne of the Brillion News regarding the Village meeting and event coverage provided and she thanked him for his dedication to the community!
- Outagamie County Highway Department Soil Hauling Agreement —Motion made by S Byers with a second made by T Schaeuble to move the Discussion/Action on the Soil Hauling Agreement with Outagamie County Highway Department, for \$93,300, to haul 25,000 cubic yards of fill and strip an area approximately 400' x 900' for a cost of \$10,000, until after the closed session. Motion carried.
- Cty Hwy ZZ Change Order –Motion made by S Byers with a second made by T Schaeuble to approve the Cty Hwy ZZ change order which includes the addition of 1,525 feet of 5' sidewalk to connect the parapet walls and staining of the wall backs, at an estimated total cost of \$84,560.14. Option of staining is for a one color application, rather than leaving natural concrete exposed, for aesthetic and maintenance purposes. Also proposed is a sidewalk running from the parapet wall from the Village garage to the Mallard Rd parapet wall. Cost of the staining is \$29,560.14. Cost of sidewalk installation is \$55,000. Funds to pay for the project are to come from the Economic Development/Marketing Expense General Fund budget line. Village is to maintain the wall/sidewalk as part of the Village trail system. Property owners along the trail have all approved the project. Brown County has agreed to pay half of the \$500,000 proposed expansion of the trail, constructed of gravel, going from Mallard Rd. north, but the cost of the remaining half is up in the air since the Town of Wrightstown has declined to participate. Trustee Mark Leonard stated that spending \$30,000 for staining on the river side of

- the wall is not a good value. A request was made by Trustee Dan Segerstrom that a less expensive erosion resistant path surface be investigated, especially since this portion of the project was not budgeted for. **Motion died due to 7 no votes.** Trustee Keith Wendlandt asked that additional options be brought back before the board at a later date
- Northeast Asphalt Proposal for Village of Wrightstown Overflow Parking Lot Motion made by S Byers with a second made by M Leonard to approve the proposal from Northeast Asphalt for \$40,320.00, to grade, water and compact 2,467 square yards of existing base and construct a two-course 3" average depth asphalt pavement, consisting of a 1 3/4" lower course and 1 1/4" upper course, with striping, for the new Washington St. parking lot. **Motion carried.**
