Robert & Joyce Lamers have requested that 1.03 acres of their property be annexed with the intent that Eric and Leah Welhouse will purchase and combine with their Village of Wrightstown parcel VW-53-7, at 15 Red Clover Ln. The remainder of the Lamers property will not be annexed. Motion carried.
- Midwest Expansion, LLP Dividing CSM Motion made by D Segerstrom with a second made by K Wendlandt to approve dividing CSM for Midwest Expansion, LLP, for Village of Wrightstown Parcel VW-W177, 4554 Cty Hwy DDD.
