## Wrightstown School District Initiative to Prepay Debt -

S Byers indicated that she had written another opinion piece that will be in the July 19<sup>th</sup> edition of the Wrightstown Sprit. The article focuses on the Schools 26.5% increase in equalized value over the past three years. The additional money collected goes to pre-pay a 20-year debt with a 2 percent interest rate.

T Coenen said that he had asked to set up a meeting with the schools new Administrator. He would also like to see a local official's meeting. T Coenen said that he doesn't want the Wrightstown School district Initiative to Prepay Debt on the agenda anymore. He feels that continuing to talk about this subject is not forming community.
