- 2023 Final Net Mill Rate, Outagamie Cty = 15.78
- 2023 Final Village Mill Rate: **6.73** from **9.04** in 2022 (Brown Cty)
- 2023 Final Village Mill Rate: 5.77 from 8.33 in 2022 (Outagamie Cty)
